<p>Description of the event :</p> <p><u>General information :</u></p> <p>Target group: all involved partners who invited interesting and interested citizens from all over Europe and EU. Participants came from municipalities, science and civil society</p> <p>Date and duration of the event: 21st of March 2024, from 1:30 pm until 3 pm.</p> <p>Objectives :</p> <ul style="list-style-type: none"> ▪ Conclusions that can be drawn from the IASH's network's experience until now ▪ Strengthen the cooperation between municipalities and its local civil society groups ▪ Promoting the exchange of best practices around the topic of migrant and refugee inclusion in European cities ▪ actively including local civil society groups the projects wants to ensure an active citizen participation at the local level ▪ reinforce the role of local and regional authorities in the European integration process. ▪ widen the network IASH, linking new members of the network. <p>The online-meeting took place on te 21st of March 2024. Over 101 citizens from more than 7 countries participated in this meeting. Every involved project-partner knew the program and his/her tasks and responsibilities. The moderation of the meeting and the communication in the chat was assured. Important aspects are documented. During the online event we engaged with political and administrative representatives from municipalities, activists, civil society, EU institutions working in the field of migration. We wanted to give the opportunity to interested stakeholders, activists, civil society, and municipalities that can not easily join the in situ activities to engage in the discussion and exchange of best practices of reception of refugee receptions in cities. As part of this working package we also wanted to share experiences in municipal engagement: we shared and discussed best practices in which municipalities work hand in hand with civil society.</p> <p>The event started with welcoming words by Lea Rau (Berlin Governance Platform), explaining the context of the event and the need for best practice exchanges. In the closing words, attention was drawn to the IASH and upcoming Cities4Refugees events. The core of the online meeting were the five breakout sessions, each presenting and discussing one specific best practice. The following overview shares insights into these sessions :</p>

Key-learnings and interesting insights:

- Need to expand the program to other countries and groups of refugees
- 2 cities which did not take part in the first pilot phase of matching last year would be open to participate in the next round → now that there are first empirical findings and experience with the tool → shows that the pilot phase of Re:Match really helped municipalities gain trust and a better idea of matching

- Importance of involving migrant / homelessness people in every part of the project.

Key-learnings and interesting insights:

- Utrecht developed a new model for 'contextual asylum centres' that follow an inclusive approach and benefit both refugees and other residents. In order to be successful you
 - need to know the neighbourhood (and the challenges it faces) in which the center will be established
 - need to know about local, national and EU funding opportunities
 - need to work with the most qualified people you can find in order to make the project successful

Key-learnings and interesting insights:

- Successful digital street work requires people who have access to the communities. Without knowledge of how the communities organize themselves, communicate and where they get their information from, effective and meaningful counseling services cannot be provided. Public administration is therefore dependent on cooperation with civil society, which can provide this expertise.
- On the other hand, direct communication between civil society and the administration should ensure that structural deficits that become apparent in the course of the consultation are addressed by public policies.

Key-learnings and interesting insights:

- Direct EU Funding too often only for short action on the ground, no long term planning is possible, but long term planning would be necessary for more sustainable structures and policies, it would be also important to include a meaningful participation and co-design with CSO and marginalized groups for sustainable integration policies.
- Support to CSO by cities depend on political will; it is necessary to create structure of funding for CSO that are independent from political will. In this case a fiscal decentralization is important
- Zagreb learned a lot how to apply for and distribute funding by joining int city networks, as Eurocities.
- Joined advocacy efforts by city networks (nat and int) are very important as cities are first respondents to local needs and know best what is needed and how

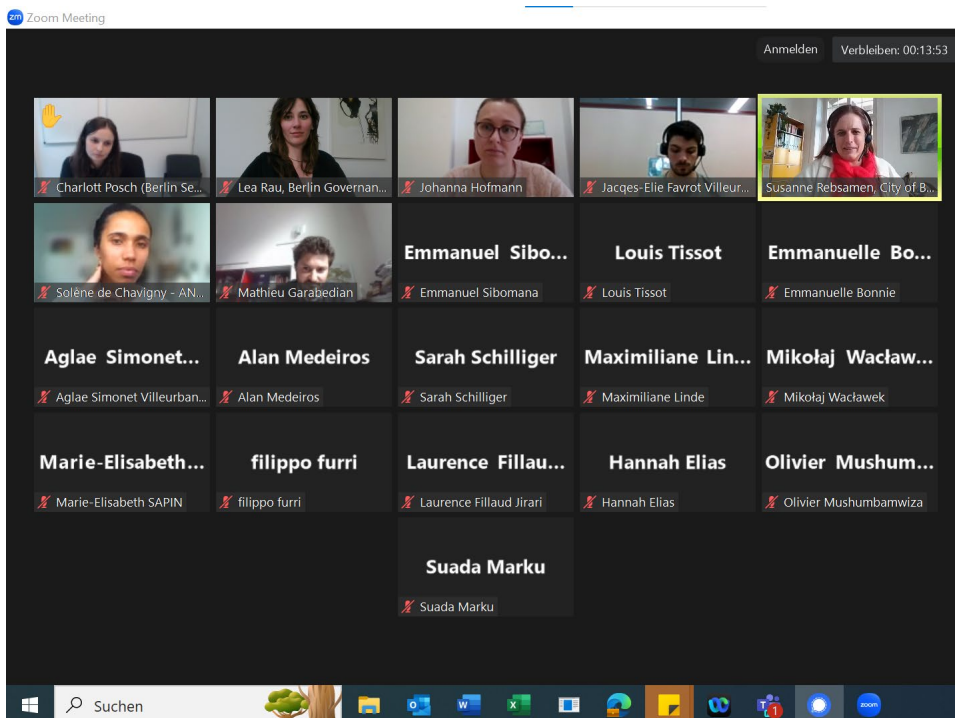
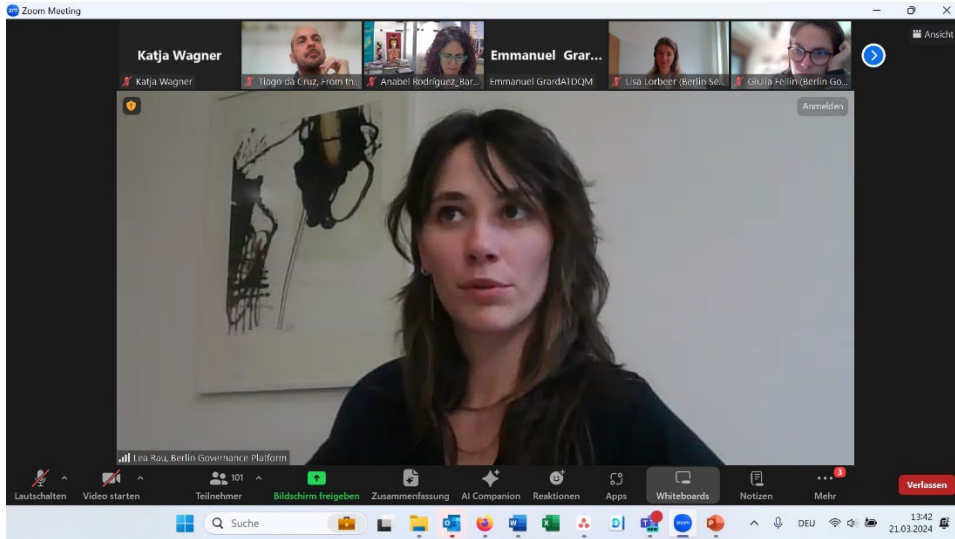

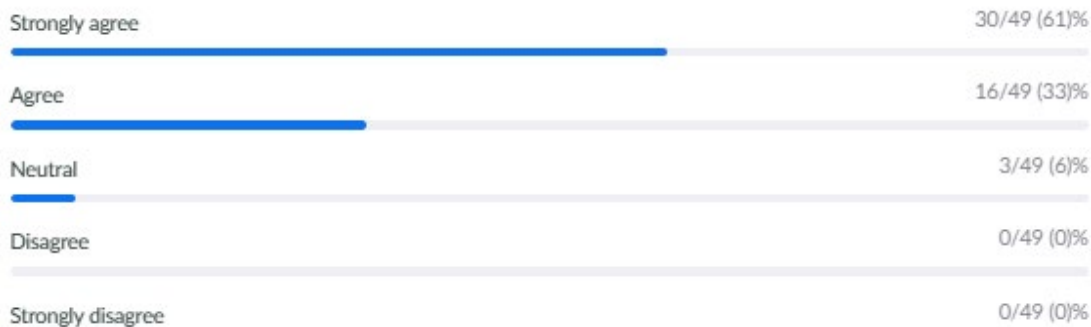


Evaluation

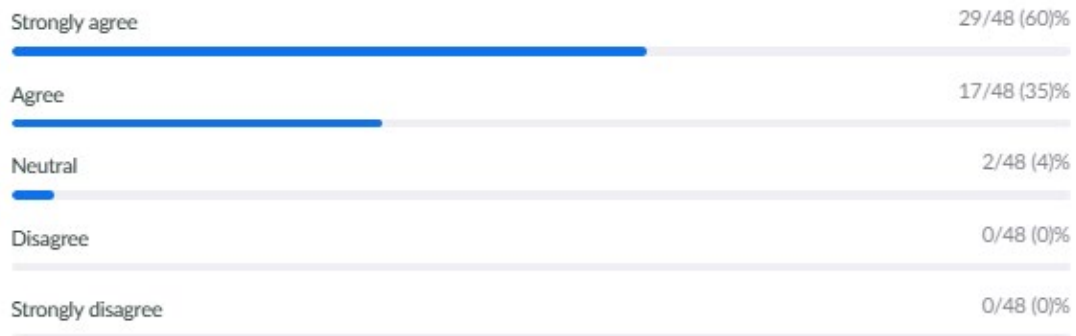

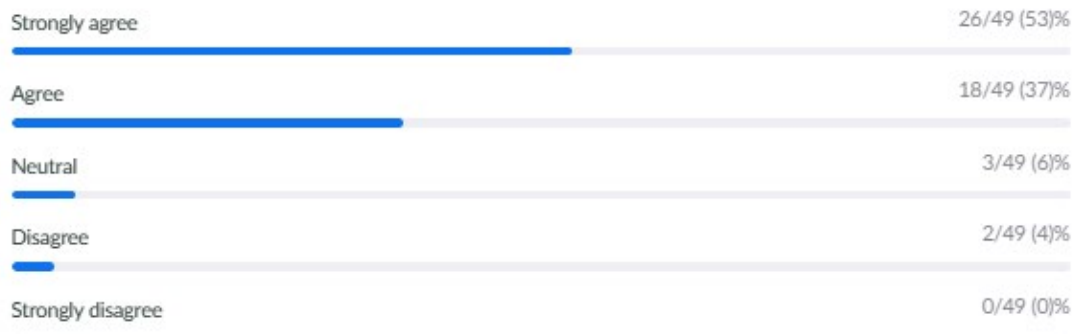

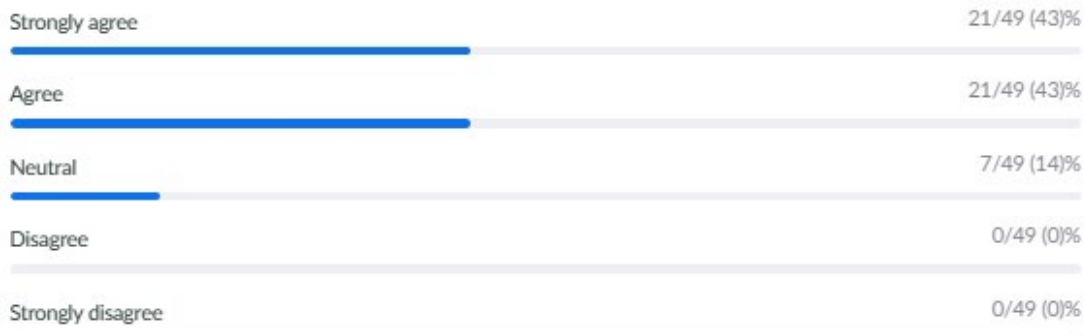
